## **ERADIFLY GRANULAR**

### **ACTIVE INGREDIENT**

Novaluron 0,2 % (IGR -insect growth regulator)

### **PRODUCT INFORMATION**

ERADIFLY GRANULAR is a larvacide with specific properties developed for the control of flies in manure and other breeding sites. ERADIFLY GRANULAR provides effective control in cattle operations. Fly control in cattle operations should include appropriate sanitary and management practices to reduce the number of size of insect breeding sites.

ERADIFLY GRANULAR affects only developing immature stages by disrupting the molting process. Consequently, fully developed adult stage of pest and beneficial species are not affected. The elimination of adult insects occurs gradually and become visible one to two weeks after application.

### **WARNINGS**

- Prevent contamination of feed or water troughs.
- Do not apply directly ERADIFLY GRANULAR to livestock or livestock feed as illegal residues may result.
- Do not feed manure treated with ERADIFLY GRANULAR to animals.
- Causes moderate eye irritation.

### **PRODUKINLIGTING**

ERADIFLY KORRELS is 'n larwedoder met spesifieke eienskappe, ontwikkel vir die beheer van vlieë in mis en ander broeiplekke. ERADIFLY KORRELS bied doeltreffende beheer in veebedrywighe. Vliegbeheer in veebedrywighe moet toepaslike sanitêre en bestuurspraktyke insluit om die aantal en grootte van insekbroeiplekke te verminder.

ERADIFLY KORRELS affekteer net die ontwikkeling van onvolwasse stadiums deur die versteuring van die vervellingsproses . Gevolglik word ten volle ontwikkelde volwasse stadium van plaag-en voordelige spesies nie geraak nie. Die uitskakeling van volwasse insekte gebeur geleidelik en is sigbaar een tot twee weke na toediening.

### **WAARSKUWINGS**

### FIRST AID

#### Oë

- Hou oog oop en spoel stadig en versigtig met water vir 15 - 20 minute.

#### Vel

- Verwyder besoedelde klere.
- Spoel vel dadelik met baie water vir 15 - 20 minute

#### **DIRECTIONS FOR USE: Use only as directed**

ERADIFLY GRANULAR is designed for dry scattering. It can be used alternatively with fly adulticides and is an important component of any integrated fly control programme.

#### **Application sites**

Apply only on fly breeding sites. It is not intended for application to fly resting sites (walls, ceilings, etc.), as it has no effect on adult flies.

#### **Application method**

Dry scattering – apply directly and evenly on the insect breeding sites. Wear gloves when scattering.

#### **Application schedule**

The recommend treatment interval depends on management and housing systems as well as on climatic conditions. More specific recommendations are given in the application schedules below.

#### **Cattle Operations**

Apply NOVALURON 0.2G directly to fly breeding sites around round hay bales, dairy barns, cattle feedlots, and all other premise areas where flies can breed. Apply 26 g/m<sup>2</sup>.

Apply NOVALURON 0.2G approximately 3 days after manure removal and repeat treatment after each removal or when fly larvae are found.

#### **Application rate**

Scatter granules at a rate of 26 g per m<sup>2</sup> of soil. Best results can be expected in wet soil, with enough animals present to trample the granules into the soil.

#### **Aanwendingsdigtheid**

Strooi die korrels teen 'n digtheid van 26 g per m<sup>2</sup> grond. Die beste resultate kan verwag word in nat grond, met genoeg diere teenwoordig om die korrels in die grond in te trap.
