Levamisole HCl 37,5 mg/ml

Praziquantel 18,8 mg/ml

### INDICATIONS

Roundworm and tapeworm remedy for sheep, goats, cattle and ostriches.

### WARNINGS

- DO NOT SLAUGHTER ANIMALS FOR HUMAN CONSUMPTION WITHIN 7 DAYS OF TREATMENT.
- No worm remedy should be dosed to sheep and goats that have not been immunised against pulpy kidney.
- When treated with levamisole, the odd animal may develop an allergic-type reaction of a transient nature which normally disappears within 24 hours. An antihistamine may be administered. Under no circumstances must cortisone preparations be used.
- Keep out of reach of children, uninformed persons and animals.
- Although this remedy has been extensively tested under a large variety of conditions, failure thereof may ensue as a result of a wide range of reasons. If this is suspected, seek veterinary advice and notify the registration holder.
